Price Determination of the Global Offering

The Offer Price is expected to be fixed on or around Wednesday, 27 February 2019. Applicants are required to pay the Maximum Offer Price of HK\$2.48 for each Hong Kong Offer Share together with brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%. If the Offer Price is not agreed between the Company and the Price Determination Bank (for itself and on behalf of the Underwriters) by Monday, 4 March 2019, the Global Offering will not proceed and will lapse. Applications for Hong Kong Offer Shares will not be processed and no allotment of any Hong Kong Offer Shares will be made until the application lists close.

If the Company decides to set the Offer Price after making a Downward Offer Price Adjustment (a reduction of up to 10% below HK\$2.00), the Company will separately announce the final Offer Price no later than Tuesday, 5 March 2019 on the website of the Stock Exchange at www.hkexnews.hk and the Company's website at www.yincheng.hk.

Publication of results

Irrespective of whether a Downward Offer Price Adjustment is made, the Company expects to announce the Offer Price, the level of indication of interest in the International Offering, the level of applications under the Hong Kong Public Offering and the basis of allocation of the Hong Kong Offer Shares on or before Tuesday, 5 March 2019 in the South China Morning Post (in English) and the Hong Kong Economic Times (in Chinese) and on the websites of the Company at www.yincheng.hk and the Stock Exchange at www.hkexnews.hk. The results of allocations and the Hong Kong identity card/passport/Hong Kong business registration numbers of successful applicants under the Hong Kong Public Offering will be available on the above websites.

The allocation of Offer Shares between the Hong Kong Public Offering and the International Offering will be subject to reallocation as described in the section "Structure and Conditions of the Global Offering - Reallocation" in the Prospectus.
